

Adoption through Collaborative Partnerships (ATCP)

Goal: *Increase the number of adoptions and timeliness to adoption permanency for a subset of eligible children in the custody of LDSS who had their parental rights terminated and who have the goal of adoption; to utilize specific adoption milestones and provide services that prepare children and families for successful adoptive placements and finalized adoptions; and to support families through the stages of the adoption process. Subrecipients can assist LDSS if they have a collaborative agreement in place, regardless of the region. Subrecipients support but do not replace adoption-related responsibilities of custodial LDSS.*

Services Provided: *Recruitment, Pre-Placement Services, Post Placement Support and Supervision Services, Assistance with Finalization Process*
